- Extended Hours access integrated into networks

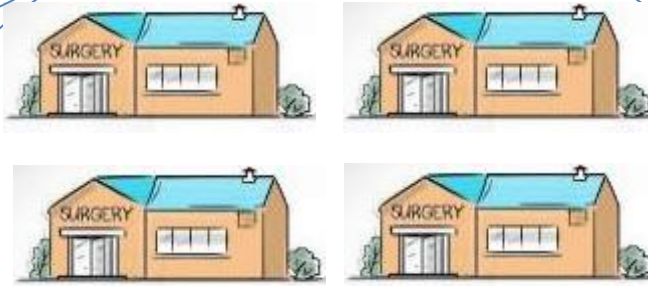
- **2020**
